1. Summary

Inspire Development Centers (IDC) is requesting sealed bids for site development work on it's project in Wapato, Washington. This project is federally funded by the Department of Health and Human Services, Administration for Children and Families, Migrant Seasonal Head Start and Migrant Early Head Start Program and subject to federal, state and local requirements.

IDC has leased a property located at 141 French Lane in Wapato, WA (Parcel 19111432401) Additionally, Inspire has purchased a 140 x 56 Modular Complex from Pacific Mobile that will be delivered and installed at the property. Pacific Mobile will also be installing the concrete foundation for their building. The facility will be used to provide Head Start services. IDC is seeking sealed bids for site development according to the approved Site Plans along with the supplementary documents listed in Attachment A.

Change orders describing the nature of the change shall be signed by both the Owner and Contractor (and/or their authorized agents or representatives) and any agreed change in the Contract Price shall be shown thereon.
